## 2024 Annual General Meeting of the Wellington Beekeepers Association 3 July 2024

- 3. Minutes of previous AGM. Noted

- 5. Presidents Report. Noted. Moved to be accepted
- 6. Treasurer's Report John Burnet presented the accounts. AFB reimbursement fund has a balance of \$13800. John suggested that some of the AFB levy funding that is not spent on AFB reimbursement could be used to support local AFB research. Discussion on this topic ensued and members agree this should be a topic for a monthly meeting. Committee to develop some proposals and present at a future time. John Burnet moved the Financial Accounts be accepted, seconded Tricia Laing.

#### 9. Membership Fee

#### 10. AFB Fee and infected hive reimbursement

John moved a motion that the reimbursement amount be raised to \$200 to better reflect the costs of new hiveware. Seconded Jane Harding. Carried.

#### 11. Review of Constitution

James Scott advised members of the work that he was undertaking to revise the constitution to bring it into line with the new Incorporated Societies Act which takes effect in 2026. The revised constitution will be circulated to members in time for it to be reviewed and adopted at the 2025 AGM.

### 12. General Business There were no items of general business raised.

Meeting closed at 8.05pm.

### **AGM – Presidents Report**

This is my President's report for the Wellington Beekeepers' Association's 85th Annual General Meeting.

This is my first year as president of the Wellington Beekeepers' Association and I find myself still settling into the position. My heartfelt thanks to Frank Lindsay who can always be relied upon to offer sage advice and step into the breach when disasters such as me forgetting what day it is occur. James Scott has done some great work rewriting the club constitution. There is a legal requirement to do so and for it to be adopted prior to January 2026, there will be some discussion about this at the Annual General Meeting.

I would like to draw your attention to a proposed change in the Constitution

7.13 A member of the Association may serve up to seven (7) consecutive years in any one office on the Executive Committee. Service beyond seven years is subject to being elected unopposed at each AGM however no member may serve more than ten (10) consecutive years in the same office. John Burnet has decided to stand down from his role as treasurer, a position he has held in excess of 10 years. I can't stress enough what a great job John has done in this role and how much his work is appreciated. We are hoping to divide up the various jobs he performs so the role is less onerous for the next incumbent.

I would also like to thank Tricia Laing and John Burnet for the work they have done advising the local councils regarding new Bylaws. I understand that Wellington City Council Bylaw has been finalised with beekeepers allowed a maximum of 4 hives per section. Porirua City Council has also finished public consultation and reported they expected to formally adopt a limit of a maximum of 4 hives per section. The definition of nuisance has been updated with an explanatory note providing examples. The Bylaw will come into effect on 1 July. Both WCC and PCC have expressed their thanks for help with consultation and expect to work with WBA in the future and take advantage of offers of training and assistance offered.

Our membership numbers continue to decline so it's great to see some new, very keen members attending the beginner classes and the main meetings. We don't do exit surveys so can only guess at the continued decline in membership. It appears to be relatively recent members so we surmise that beekeeping is not as easy as people assume and keeping on top of varroa in particular is challenging. With the continued difficult economic situation it can be expensive to buy all the equipment and treatments required. Throughout the year new members continue to have the opportunity to gain hands on experience at the club hives in Chartwell and Wingate. Thanks to Frank Lindsay, John Burnet, Richard Braczek, Michele van Daalen and Reb Bakker for their supervision of these hives.

Frank Lindsay and John Burnet again ran a successful Beginner's course in September/October 2024 attended by 12 participants.

Varroa continues to be the single biggest challenge to successful beekeeping at the moment. We are incredibly lucky to have the expertise of Frank Lindsay to advise us on the latest treatments — what they are and when to apply them. We have also benefitted from keeping up with what is going on with bee-related research at Victoria University under the supervision of Phil Lester.

Finding meeting topics which are interesting and topical for the vast range of experience of club members continues to be a challenge, if anyone has any suggestions the committee are always keen to hear them. Highlights of the previous year have been Zoe Smeele's update on her research into using pathogen-specific double-strand RNA molecules to target varroa; Richard Braczek's presentation about making mead; the video evening watching "Honey Bee Democracy" and Mark Wendelken's presentation about climate change titled "The Bigger Picture" which I regretfully missed but which was reportedly sobering and compelling.

I have previously voiced my appreciation for the contribution of various Committee Members during the year, but I wish to acknowledge in particular: Jane Harding for her work as Secretary, James Withington for continuing to keep our Facebook page up-to date; our new librarian Tatjana Manabe who has taken over from Ellen Millar; Jim Hepburn for managing the swarm list, John Burnet for his ongoing work in all things financial (accounts, honey testing, varroa treatment sales) as well as his contribution to helping new beekeepers and Eva Durant for undertaking the accounting review; Graham Chisnal for sharing his knowledge and experience with new beekeepers in many of the Beginners' Classes, and Barbara Parkinson and Liz Tan for their excellent catering.

### **Disposal of Old Hiveware**

The Club is proposing to organise an old hive-ware collection and disposal project similar to one held by Auckland beekeepers recently. We will collect this unwanted and possibly contaminated gear from your property on a pre-arranged date and time and organize its safe destruction. This helps to reduce the risk of spreading AFB (American Foulbrood), the spores of which can linger and survive in used hive-ware for over 50 years. To cover costs there will be a fee of \$5 per box or bin bag containing any old hive-ware or equipment that may be contaminated.

To determine viability of this project and effort/resources required, we need to determine how many members are interested in participating and how much gear they will have for collection/destruction. If you are keen to participate please advise the Treasurer by email

# **Establishment of NZ Bee Health and Biosecurity**

Industry announcement – AFB Management Agency to become New Zealand Bee Health & Biosecurity (NZBB)

#### 27 June 2025

Formal announcement to industry

The Board of The Management Agency National American Foulbrood Pest Management Plan (The Management Agency) is pleased to inform the apiculture industry of the formation of New Zealand Bee Health & Biosecurity (NZBB), a charitable trust that has been appointed by the Minister for Biosecurity as the management agency for the Biosecurity (National American Foulbrood Pest Management Plan) Order 1998 (AFB NPMP), under section 100D of the Biosecurity Act 1993.

#### From The Management Agency to NZBB

To ensure a smooth transition, this strategic change will be led by the existing AFB NPMP Management Agency Board and executed by Niharika (Niha) Long, who will become Chief Executive of NZBB.

The new entity will assume all the current responsibilities of The Management Agency in supporting New Zealand beekeepers' efforts against American Foulbrood (AFB).

In addition to taking over The Management Agency's compliance activities,

NZBB will continue to focus on AFB-related training and education, and consult with the sector on the merits of gradually expanding its scope to general honey bee disease management.

Pending a sector-wide consultation and support from beekeepers, NZBB will also facilitate biosecurity preparedness for exotic bee pests & disease incursion, in collaboration with other primary industry partners and Biosecurity New Zealand. Details of this consultation will be announced once confirmed.

#### What will change?

Aside from its activities related to administering, operating, and achieving the objectives of the AFB NPMP, NZBB will also:

- advance education and awareness in the industry on the management and prevention of AFB,
- set up Advisory Groups (AG) as a communication channel between industry and the NZBB Board of Trustees and to acquire specialist knowledge and expertise from beekeepers on issues of significance to the sector,
- collaborate with horticulture industry partners who rely on pollination services to improve hive health and traceability for managing AFB levels,
- collaborate with public agencies and research organisations for new tools that aid in the elimination of AFB,
- train and educate new and existing beekeepers on biosecurity practices that instill preparedness for AFB outbreaks.

It is expected that the above changes will eventually prepare the industry for the arrival of novel bee pests & diseases. We are supporting this organizational change with the launch of a new NZBB website, enabling us

to provide credible, current information that is accessible, understandable, and actionable for beekeepers.

Please note that the new name and branding will undergo a phasedrollout across all our current communication channels with beekeepers.

#### What will stay the same?

While the name and look of our organisation have changed, our committed team of Apiary Coordinators, Operations Managers, Training and Levy Coordinator, Authorised Persons, and AFB Recognition course trainers will continue to deliver our services. Many of our team are beekeepers themselves and look forward to gradually expanding our scope to provide a more comprehensive service to NZ beekeepers in their vigilance against honey bee diseases.

NZBB will continue supporting beekeepers by:

- Implementing the AFB NPMP to achieve the objectives of the NPMP and supporting beekeepers with their statutory obligations;
- Running the AFB Recognition Training course; AFB Recognition refresher course; and the Commercial AFB refresher course,
- Continuing to empower beekeepers with the right tools and support for dealing with AFB incidences, and
- Monitoring beekeeper compliance with the AFB NPMP and taking compliance and enforcement actions, wherever appropriate.

#### What does this mean for beekeepers?

Beekeeper levy funds will continue to exclusively fund the implementation of the AFB NPMP.

Our gradual inclusion of focus over time on general honey bee diseases aligns well with our existing resources and training. When we advise and support beekeepers to keep on top of inspection, quarantine, and traceability protocols, we are supporting beekeepers to develop proactive honey bee disease management. These skills apply to AFB, general honey bee diseases, and exotic bee pests and diseases.

We are confident that this new structure will enable us to work towards a more collaborative and resilient beekeeping industry that is actively prepared to fight honey bee disease incursion and is sustainable for the future.
